Michigan Governor Gretchen Whitmer has signed into law Senate Bill 1108 – the legislation that amends the Open Meetings Act that allows public bodies to conduct public meetings remotely during the COVID-19 pandemic. ***The Village of Lake Orion will not allow in-person attendance*** at this meeting to mitigate the spread of COVID-19 and provide essential protections to vulnerable Michiganders and this state’s healthcare system and other critical infrastructure.
