NOTICE IS HEREBY GIVEN that in accordance with Community Development Block Grant (CDBG) requirements, the Village of Lake Orion Village Council will hold a public hearing on the use of Community Development Block Grant Funds. The Hearing will be held on Monday, November 23, 2020, at 7:30 p.m. for the purpose of hearing public comments on the Community Development Block Grant (CDBG) Program Year 2021 application in the approximate amount of \$9,333 to fund eligible projects. ***The Village of Lake Orion will not allow in-person attendance*** at this hearing to mitigate the spread of COVID-19 and provide essential protections to vulnerable Michiganders and this state's healthcare system and other critical infrastructure.
