RE: <u>VILLAGE MANAGER'S REPORT</u>

ATWATER STREET PEDESTRIAN CROSSING SIGNAL

The parts for the damaged pedestrian crossing signal have been ordered through Carrier and Gamble, and the reinstallation of the signal will be completed by the village's electrical contractor, Darren Myers of Electrical Systems, Inc. The parts will be delivered, and work is expected to be completed, in approximately six weeks.

FY 2023-24 BUDGET PREPARATION

Department directors will be submitting their budget requests to my office for review by February 24. At your March 27 regular meeting, council will be asked to schedule budget work sessions during the period of April 11-18 to review the proposed budget.

ZONING CODE UPDATES

McKenna is working to consolidate all previous zoning code amendments into one new code document, and the work to update the code should be completed by the end of the month.

WEB SITE REDESIGN PROJECT

Council recently authorized changes to the CivicPlus statement of work to upgrade the village's web site redesign from the "premium" package to the "ultimate" package. This change in scope of work will result in a delay in rolling out the new site as the company and village administration work to design and add content to the site. I am hoping that the new site will be available by mid-March.

DDA DOWNTOWN DEVELOPMENT BONDS

As council is aware, administration is working to resolve questions and concerns regarding the proposed DDA Downtown Development Bonds issuance. A number of legal questions linger, including the sufficiency of the petition submitted by Harry Stephen to repeal the ordinance

extending the term of the DDA, whether the township clerk or village clerk is responsible for certifying the petition, whether charter language limits the ordinance referendum period to a definite period of time after adoption of the ordinance, staleness of signatures, potential conflicts between state election law and charter provisions relating to ability to obtain supplemental signatures after the original filing of the petition, and whether the petition should be forwarded to the county clerk for processing. Village Attorney Kucharek and I will keep council apprised of our work on these matters.

Meanwhile, DDA Executive Director LaLone has scheduled an administrative public informational meeting to present the details of the lumber yard redevelopment project to the public, answer questions, and engage in a dialogue regarding the project.

INTRODUCTORY MEETING WITH SUPERINTENDENT OF SCHOOLS

I had the pleasure of meeting with Lake Orion Community Schools Superintendent Ben Kirby on January 26 at my office. We discussed the importance of maintaining a close working relationship and timely communication on important topics. I look forward to our continued partnership.
